The undersigned agrees to maintain a current valid credit card on file with the Club at all times, and hereby authorizes the Club to charge such credit card for any amounts owed to the Club, including amounts reflected on monthly invoices, that are more than Forty Five (45) days past due. Should legal action be required to collect amounts due, I the undersigned will reimburse NHCC for its reasonable attorney's fees and other costs of collection. Any unpaid amounts will bear interest and be subject to late fees in accordance with NHCC policy.

If the undersigned is suspended from NHCC for any reason, including non-payment of dues, he/she will forfeit all future dues credits.

The undersigned hereby acknowledges and agrees that he/she is personally liable and responsible for all financial obligations relating to his/her membership, including any obligations relating to the use of the Club by his/her family members and guests.
